- 5. Bids must be valid for a period of 90 days after bid opening and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned above, which shall be valid for 30 days beyond the validity period of the bid.

If bidder wishes to submit the Cash Security, the cash should be deposited in Dharauti Khata No. 0570300000000000387 of Chautara Sangachokgadhi Municipality Office, Chautara, Sindhupalchok in the Office Code No. 23-365-14 of Nepal Bank Limited, chautara Branch and submit the receipt of the deposited amount of cash along with the Sealed Bid.
