- 4. Sealed Quotations must be submitted to the office on mentioned above. Quotation received after this deadline shall not be entertained.
- 5. Quotations must be valid for a period of 45 days after opening of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned above, which shall be valid for 75 days after opening of the Sealed Quotations.

If bidder wishes to submit the Cash Security, the cash should be deposited in Dharauti Khata No. 057030000000000387 of Chautara Sangachokgadhi Municipality Office, Chautara, Sindhupalchok in the Office Code No. 23-365-14 of Nepal Bank Limited, Sindhupalchok Branch and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
- 7. Sealed Quotation shall be opened in the presence of Suppliers' representatives who choose to attend at *above mentioned date and time at* the office of *Chautara Sangachokgadhi Municipality.*
- 8. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
